I want to report and to complaint
an incident that happened to me on
Tuesday, september 12, 2023, while I was
working as a taxi driver and I was
in working hours, and which continued
for the following days.

On september 12, 2023, as I was passing
by with the taxi that I work as a
driver at around 22:30 P.m. o'clock
(at the time I was working) from Ermou
Street and heading from Thessio to
Athens street, at the height of
Monastiraki square and as I was stopped
at the traffic light in point that

it happened to be red, a foreign potential customer approached the taxi I was driving and through the open passenger window asked me (2) twice if I would going him to his destination, of course I would going whatever route it was I had not other customer in the car I was free and I had open the lights of the free indicator, but he spoke very broken Greek and I was trying to understand which his destination was, which was the point where he wanted to go to, (I speak good Greek which is my mother tongue and speak and understand English in an intermediate level) at the same moment someone else (seemed to be a foreigner) approached the open window of the passenger and speaking

in greek that I could understand ,
he told me that the potential client's
destination was the phlisvos in the
area of Paleo Faliro , from the moment
I knew the destination I told the prospective
client to board the taxi I was driving
to start the route , the prospective
client before he board asked me how
much the trip would cost and I told
him that the taxi fare meter would
write about 15.00 euros (depends always
and from the traffic) , he seemed to
agree and I waited for him to board the
taxi I was driving to start the trip,
then appeared there some taxi drivers
who park illegally at the spot in front
of Monastiraki square , which is slightly
ahead of the legal taxi rank that

exists there, turn off from their cars the lights of the free indicator and illegally pick customers, illegally do not use the taxi fare meter for the legal charge of each route, they charge more than the legal cost the customers and illegally they do not issue receipts (at least not legal receipts, legal receipts are issued only by the cash machine that is connected to the taxi fare meter) and they acting as gang snatched (grabbed) the potential customer from me and some of them told to me that when I pass by there with the taxi not to stop other time for customers because there, are they (the illegals), (from Monastiraki square to Phlisvas - Paleo Faliro is considered to be and is a good route for the taxi, is a long

distance route and in the most part have open road), without getting out of the car, I reacted verbally and from the open window of the passenger seat I told to them some swear words, and then they retreated, I said and some swear words and for the police officers which were there in some only meters distance and that in front of their eyes gangs of illegals are ravaging the area without them reacting to impose order, obviously they would have illegal benefits (with cheap money such as cigarettes, coffees, and possibly small amounts and flattering words from the illegals). After they retreated, I continued on my way (I was stopped in the middle of Ermon street after

a while, passing again from the Point with direction from Athens street to Thessio, I stopped at the edge of Ermou street (so as not to obstruct the movement of vehicles) to complain the incident to the police officers who were there, but they noticed me because I stopped to report the illegals and they also noticed me because I spoke to them, then going back to the taxi car I am renting I called from my mobile phone (at around 22:30 P.M. o'clock) the center of Police immediate action (100) and I denounced, without mentioning my name, the taxi drivers and the police officers who were there in front of Monastiraki

square and I also mentioned the license plate number of the Police bus (EA 20326) which was parked on the Ermou street behind from the legal taxi rank, the Police officer I spoke to on the phone told me that they would notify the traffic Police to deal with the matter and advised me to ask the Police officers who were there for the name of the officer who was the head of their team, then I turned the car taxi I was driving (license plate number TAB 2243) in the direction from Thissio to Athens street (so as not to obstruct the movement of the vehicles) I got out of the taxi and addressed the Police officers and the officer who was their leader, I asked him to tell me his name because

I wanted to make a written complaint about the incident the Police officers and the head officer of the team, however, with the style which have the illegal and financed Police officers who have cover from their superiors and are in hiding (I worked in the greek Police for (9) nine years but I was a professional Policeman and completely legal, never financed) again they noticed me because I stopped (they claimed that I was obstructing the pedestrian crossing) and they refused, as did the same officer who was there, to tell me their names, after I informed them that I would make a written complaint (I am completely legal, I have never hidden in my life) I left in the taxi that driving from the Point and I tried to

contact the Police immediate action center (100) again by my phone, but they did not answer me, I was on hold for more than (5) five minutes and nobody answered me and I did not have the time to wait any longer, I had to continue my work.

The following night on September 13, 2023, around 23:00 P.M. o'clock I passed again from the Point Monastiraki square working as driver with the car taxi that I rent, and again, as every night, the same phenomenon with the illegal taxi drivers and illegal Police officers were happening there, I called the Police immediate action center (100) from my mobile phone and I again denounced the illegal phenomenon, and passing by in the taxi I took with my phone

Five Photos^(1,2,3,4,5) to prove what I am writing, then two of the illegal police officers who were there (the girls in the blue uniforms) I have the impression, without to have give any particular importance, that they made obscene gestures against me, that they wanted to show me their Pussies because balk they have not.

If you ask them for their written reports, as I will do with a related complaint to their service, you will find that they will write lies on their papers, they will tell lies and they will sign their lies, they will show their pussies.

Some of the following days, an afternoon with the taxi car that I work as driver and while I was free I stopped at the legal taxi rank that exists in Monastiraki

Square and waited for a customer, in a short time came some foreign

Potential customers who wanted to go to the Port of Piraeus and they asked me about the cost of the route, I answered them that the cost would be what the taxi fare meter write from 15.00 to 20.00 euros about (it depend always and from the traffic), but they seemed convinced for some reason that I would charge them with the taxi fare meter more money than the legal cost and they insisted on paying me a pre-arranged amount of 30.00 euros for the route, I tried to explain to them that the taxi fare meter would write less money from about 15.00 to 20.00 euros and that I work legally with the taxi fare meter and that I do not make trips without using the

taxi fare meter, then they refused and left to find another taxi, immediately after some Potential customers came who wanted to go to the same destination as the previous ones, at the port of Piraeus and they asked me not to pay the route according to what the taxi fare meter will write but a pre-arranged amount of 30.00 euros, I explained to them that I do not make trips without using the taxi fare meter and that I charge the customers the legal costs according to the taxi fare meter⁽⁶⁻⁹⁾, which for the specific route would be about from 15.00 to 20.00 euros (it depends always and from the traffic), finally they agreed, they boarded the taxi and I made the route legally with the taxi fare meter in operation and arriving in Piraeus the legal cost for the route

was 13.00 euros (I avoided the traffic at some points).

It surprises me that the tourists who board a taxi from Monastiraki square are so deceived for the costs of the taxi routes, I wonder, no one of them have ever asked the Police officers who are there everyday about the legal costs for the taxi routes? and I wonder in that case of question what answers the Police officers give them?

On September 19, 2023, I made a written request to the general Police Directorate of Attica to be granted me copies of the phone calls I made on September 12 and 13, 2023 to the Police immediate action center (100) and copies of the records of the incidents as I reported them and to inform me in writing what actions the Police took to deal with them, they

told me that they will need more than (20) twenty days to answer me, I will wait for their written answers.


I want to mention that the amounts of money that are trafficked from illegal activities in athen's are huge and over the years were and are involved superiors and supreme officers of the greek police and their political superiors, so I am addressing my complaint, which is also against the director of the sub-directorate measures of order, antonio's sgourdos, and against the commander of athen's traffic police, police director ioannis dimittrakopoulos and against the director of the general police directorate of attica sub-general asterias mantziokas and against their physical and political superiors and because






